Research Associate / Research Fellow

The Poverty & Race Research Action Council (PRRAC) seeks a full-time Research Associate (or Research Fellow) with strong quantitative, analytic and project management skills to assist PRRAC in data collection, quantitative and qualitative research, GIS mapping, and report preparation. The Research Associate will gather and manage data sets; conduct research and data analysis; work with government statistical agencies and private corporations to access relevant data; provide technical advice on research design; prepare data and data analysis/interpretation for inclusion in PRRAC publications; prepare literature reviews on race and poverty related issues; liaison with researchers working on PRRAC-supported research grants; and respond to and fulfill periodic data requests from reporters, agencies, government agencies, academics and others. The Research Associate will also help to train and supervise student research assistants.

Qualifications: A Master's Degree or PhD in Statistics, Economics, Demography, Sociology, Planning, Public Policy or a related field that includes quantitative data skills. At least two years of research experience in addition to academic experience is preferred for the Research Associate position; applicants for the Research Fellow position may have 0-1 years post-degree experience. The position assumes an interest in the public policy aspects of affordable housing, metropolitan development, education, environmental health and racial, ethnic and gender inequality. Analysis may encompass, for example, federal census data, HUD program data, federal and state education statistics, and state and local agency data. Applicant must have demonstrated ability to collect, analyze and interpret a range of large and small datasets. Expertise with statistical software programs (at least one of the following: Stata, R, SAS, or SPSS), experience with GIS mapping software, and facility with Microsoft Office required. We're also looking for a team player with strong writing skills, and a commitment to social justice.

Our current work is focused in the areas of housing, education, and environmental health, with a particular emphasis on the causes and consequences of housing and school segregation, and appropriate remedial strategies. In addition to national-level law and policy research and advocacy, we are engaged in local technical assistance work in Baltimore and Hartford, in support of regional desegregation cases filed by the NAACP Legal Defense Fund and the ACLU. PRRAC also supports public education efforts, including the bimonthly newsletter/journal *Poverty & Race*, and the award-winning civil rights history curriculum guide, *Putting the Movement Back Into Civil Rights Teaching*.
